**ORDER GRANTING INTERVENTION  
AND ESTABLISHING PROCEDURAL SCHEDULE**

On October 9, 1992, the Commission issued an order in this case giving notice to interested persons and establishing an intervention date. GTE North Incorporated, GTE Missouri, GTE Systems of Missouri and GTE of Eastern Missouri; United Telephone Company of Missouri; Missouri Coalition Against Domestic Violence; AT&T Communications of the Southwest, Inc.; American Civil Liberties Union of Eastern Missouri Fund; Victim Service Council; Hope House; MCI Telecommunications Corporation; NEWHOUSE; Domestic Violence Network; and Board of Police Commissioners of Kansas City, Missouri, have filed timely applications to intervene. The persons filing the applications to intervene are local exchange companies, not-for-profit corporations representing advocates which provide services to victims of domestic violence, an organization which defends individual rights, an organization which assists victims of crimes, and a board of police commissioners.

Pursuant to 4 CSR 240-2.110(14), applications to intervene may be denied if the petitioner does not demonstrate he has an interest different from the general public's, that granting the petition would not serve the public interest, or that the petitioner is not a municipality or political subdivision.

The Commission has considered the applications and finds that because of the widespread public concern over the provisioning of Caller ID, a broad range of interests should be allowed to intervene in this proceeding. The Commission therefore finds it will be in the public interest to grant the interventions.

On November 17, 1992, the parties filed a proposed procedural schedule for this docket. The Commission has considered the schedule and has modified the schedule because of conflicts with other Commission matters.

**IT IS THEREFORE ORDERED:**

1. GTE North Incorporated, GTE Missouri, GTE Systems of Missouri and GTE of Eastern Missouri; United Telephone Company of Missouri; Missouri Coalition Against Domestic Violence; AT&T Communications of the Southwest, Inc.; American Civil Liberties Union of Eastern Missouri Fund; Victim Service Council; Hope House; MCI Telecommunications Corporation; NEWHOUSE; Domestic Violence Network; and Board of Police Commissioners of Kansas City, Missouri, be hereby granted intervention in this proceeding.

2. That the following procedural schedule be hereby adopted:

Prehearing conference	January 20, 1993 beginning at 10:00 a.m.
Hearings	February 1-2, 1993 beginning at 10:00 a.m.
SWB files initial brief	February 16, 1993
Staff, Public Counsel and intervenors file reply briefs	February 26, 1993

SWB files surrebuttal brief;  
Staff, Public Counsel and intervenors  
file cross-surrebuttal briefs

March 8, 1993

The prehearing conference and hearings will be held in the Commission's hearing room on Floor 5A of the Harry S Truman State Office Building, 301 West High Street, Jefferson City, Missouri.
