ORDER APPROVING TARIFF

On April 20, 1994, Global Wats One, (Global or company) made application with the Missouri Public Service Commission (Commission) for a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri. On June 28, 1994, the Commission granted Global's application and directed the company to file its tariff within thirty (30) days. Global's certificate of authority becomes effective upon the approval of its tariff by the Commission.

Global filed its proposed tariff on July 21, 1994, reflecting the rates, rules, and regulations it intends to use for providing services in Missouri. The tariff also reflects its status as a competitive telecommunications provider, and indicates the statutory and regulatory requirements waived by the Commission pursuant to Section 392.420, RSMo Supp. 1993. On August 9, 1994, Global filed substitute sheets to amend its tariff. Global is proposing to provide switched services including "1+" long distance and travel card services.

On August 12, 1994, the Staff of the Missouri Public Service Commission (Staff) filed a memorandum giving its recommendation. Staff stated that it had reviewed the proposed tariff and substitute sheets and concluded that the tariff, as amended, clearly and comprehensively describes the terms and conditions of the services to be offered, and that those services are within the

scope of the certificate of authority conditionally granted. Staff concluded that the proposed tariff, as amended, is consistent with service offerings currently available from other interexchange carriers and approved by the Commission, is in compliance with Commission rules and regulations, and recommended that the tariff be approved for services on and after August 20, 1994.

Having reviewed Global's tariff and Staff's recommendation, the Commission finds that Global's proposed tariff, as amended, details the services, equipment, and pricing it proposes to offer, and that the proposed tariff is similar to those which have been approved for other Missouri certificated interexchange carriers providing similar services. The Commission further finds that the proposed tariff filed on July 21, 1994, and amended on August 9, 1994, complies with the Commission's order and should be approved for services on and after August 20, 1994.

IT IS THEREFORE ORDERED:

1. That the tariff filed by Global Wats One, Inc. on July 21, 1994, and amended on August 9, 1994, is hereby approved for services on and after August 20, 1994. The tariff approved is:
