

ORDER APPROVING TARIFF SHEETS

By its Order Approving Stipulation Agreement and Recommendation issued by the Commission in this matter on September 18, 1987, United Telephone Company of Missouri was authorized to file revised tariffs designed to decrease its Missouri jurisdictional gross annual revenues by \$3,200,866, exclusive of license, occupation, franchise, sales, gross receipts or other similar fees or taxes.

On September 15, 1987, United Telephone Company of Missouri submitted for approval of the Commission revised tariff sheets designed to comply with the Order of the Commission. On September 22, 1987, the company submitted amended tariff sheets as a result of discussions with the Staff of the Communications Department of the Commission. The amended tariff sheets contain rates designed to decrease the company's Missouri jurisdictional gross annual revenues by approximately \$3,201,319, with a requested effective date of October 1, 1987.

The Commission is of the opinion the proposed tariff sheets should be allowed to become effective October 1, 1987.

It is, therefore,

ORDERED: 1. That the following tariff sheets submitted by United Telephone Company of Missouri on September 15, 1987, and amended on September 22, 1987, containing rates designed to decrease its Missouri jurisdictional gross annual revenues by approximately \$3,201,319 be, and the same are, hereby approved for telephone service rendered on and after October 1, 1987.


