

ORDER DIRECTING FILING

On December 5, 2000, the Commission issued an Order Approving Financing which, among other things, directed Kansas City Power & Light Company (KCPL) to file with the Commission, within ten days of the transaction, all final terms and conditions regarding the financing. On December 21, 2000, KCPL filed a set of documents including a cover letter which stated that "[t]hese documents contain information requested in Item #2 of the Commission's Order."

The Commission directs its Staff to review the documents filed by KCPL and file a status report with the Commission stating whether in Staff's opinion this case may now be closed.

IT IS THEREFORE ORDERED:

1. That the Staff of the Missouri Public Service Commission shall file a status report with the Commission not later than January 30, 2001.

2. That this order shall be effective on January 20, 2001.
