**ORDER DISMISSING COMPLAINT**

Darla Jarman filed a complaint on March 6, 2001, against Union Electric Company, d/b/a AmerenUE. Ms. Jarman's complaint alleged that AmerenUE owed her \$660 in damages due to "high and low voltage" in her home on October 2, 2000. On June 22, 2001, AmerenUE filed a copy of a settlement agreement between Ms. Jarman and AmerenUE. AmerenUE also requested that the complaint be dismissed.

The settlement agreement indicates that Ms. Jarman received payment of \$660 from AmerenUE. AmerenUE certified in its motion to dismiss that it served the Office of the Public Counsel and the Staff of the Missouri Public Service Commission with a copy of the motion and settlement agreement on June 18, 2001. There were no objections to the dismissal.

The Commission has reviewed the settlement agreement and finds that the complaint has been satisfied and may be dismissed.

**IT IS THEREFORE ORDERED:**

1. That the complaint filed by Darla Jarman against Union Electric Company, d/b/a AmerenUE, in Case No. EC-2001-471 is dismissed.
2. That this order shall become effective on August 31, 2001.
