AT&T'S NOTICE OF WITHDRAWAL

AT&T Communications and AT&T Missouri (collectively, the "AT&T Companies"),¹ respectfully wish to inform the Missouri Public Service Commission ("Commission") that they are withdrawing their remaining objection to Neutral Tandem-Missouri, LLC ("Neutral Tandem") 's proposed tariff.

As revised, the proposed tariff sufficiently addresses the AT&T Companies' concern about Neutral Tandem's intent to follow the Ordering and Billing Forum's ("OBF's") Multiple Exchange Carrier Access Billing ("MECAB") Guidelines. While AT&T Communications, as an interexchange carrier ("IXC") customer of Neutral Tandem's switched access services, still has concerns with the added costs it and all other IXCs will be forced to incur to interconnect with Neutral Tandem, AT&T Communications believes that its concerns can be addressed through continued discussions with Neutral Tandem on a business to business basis. In the event such discussions are not successful, AT&T Communications believes its concerns would be better addressed in a complaint proceeding.

¹ AT&T Communications of the Southwest, Inc. will be referred to in this pleading as "AT&T Communications;" and Southwestern Bell Telephone Company, d/b/a AT&T Missouri, will be referred to in this pleading as "AT&T Missouri."

WHEREFORE the AT&T Companies respectfully withdraw their objections to Neutral Tandem's proposed tariff.


