COMMENTS OF THE SMALL TELEPHONE COMPANY GROUP REGARDING PROPOSED REVISION TO 4 CSR 240-18.010 SAFETY STANDARDS-ELECTRIC AND TELEPHONE UTILITIES AND RURAL ELECTRIC COOPERATIVES

Comes now the Small Telephone Company Group (STCG), a group of small local exchange companies, members of which are set out in Appendix A, and for its Comments Regarding the Missouri Public Service Commission's (Commission) proposed revisions to 4 CSR 240-18.010, Safety Standards - Electric and Telephone Utilities and Rural Electric Cooperatives, states to the Commission as follows:

- 1. On October 1, 1999, the Commission's proposed revisions to 4 CSR 240-18.010, Safety Standards Electric and Telephone Utilities and Rural Electric Cooperatives, were published in the Missouri Register. Comments regarding these proposed rules were to be filed on or before November 1, 1999.
- 2. The STCG offers the following comments regarding the proposed rule. In this rule, the Commission proposes to adopt certain provisions of the American National Standard, National Electric Safety Code (NESC). This proposed section is consistent with the recently revised 4 CSR 240-32.060, Engineering and Maintenance, also prescribing standards for design,

construction and operation of telecommunications facilities which also adopted portions of the NESC. There is one difference, however, which the STCG feels is significant. Paragraph (10) of 4 CSR 240-32.060 states that the company shall comply with the requirements of the rule "on a going forward basis." The STCG believes that this proposed revision should also state that it is effective only on a going forward basis.

The STCG appreciates the opportunity to comment on proposed rule 4 CSR 240-18.010.
