SPIRE MISSOURI INC'S RESPONE TO STAFF'S RECOMMENDATION

COMES NOW Spire Missouri Inc. ("Spire Missouri" or "Company") and files its Response to Staff's Recommendation and in support thereof respectfully states as follows:

1. On September 1, 2021, Spire filed its Application to Update its Weather Normalization Adjustment Rider (WNAR) and proposed tariff revisions JG-2022-0047 and JG-2022-0048.

2. On September 10, 2021, Staff filed its Recommendation recommending that the Commission reject the Company's Proposal and to implement Chapter 13 rules to address any over/under charges that are involved in this case.

3. On September 13, Spire filed a Response in which the Company requested additional time, until September 20 to respond to Staff's Recommendation. On September 14, the Commission granted Spire's request.

4. In response to Staff's Recommendation, Spire will, in tandem with this filing, file substitute revised tariff sheets and workpapers that remove the billing errors associated with the October 2020 through February 2021 time period. Spire's decision regarding this matter should not be construed to mean the Company agrees with all of the assertions purported by Staff in its filing. Rather than litigate this matter before the Commission at this time, the Company will instead pursue recovery through the mechanism established by the Commission under Chapter 13.

5. After removing the billing errors, the WNA for Spire East is \$0.00190 and the WNA for Spire West is \$0.00583. For the average Spire East residential customer, the charge is 13 cents per month, and for the average Spire West residential customer the charge is 37 cents per month. The actual charge will vary depending upon customer usage. The Company will immediately file a revised application to reflect these adjustments.

WHEREFORE, Spire Missouri respectfully requests that the Commission accept this response and approve the revised WNAR Tariff Sheets to become effective on October 1, 2021.
