COMES NOW New Edge Network, Inc. d/b/a New Edge Networks ("New Edge" or "Applicant"), and in response to the Commission's <u>Notice Requiring Filing (Notice</u>) which was issued November 9, 1999 files this Addendum to Exhibit 1 and Addition to List of Statutory Citations.

1. Attached hereto is the Registration of Fictitious Name from the Missouri Secretary of State's office which registers the name New Edge Networks. It was erroneously omitted from the original Application, and should be considered as an addendum to Exhibit 1 to the Application.

2. In addition to the statutory authority cited in the Application filed herein on October 29, 1999; namely, Sections 392.361 and 392.420, New Edge hereby adds reference to Sections 392.410 and 392.430. The Commission's <u>Notice</u> suggests that all sections from 392.410 through 492.455 "are the proper statutes for an applicant to cite." However, Section 492.455 could not be found in the Revised Statutes of Missouri, and appears to be a typographical error. If the intended reference is to Section 392.455, that section as well as Sections 392.450 and 392.451 refer by their terms only to "an application for certificate of local exchange service authority to provide basic local telecommunications service". New Edge seeks only interexchange and nonswitched local exchange authority in this Application–New Edge does not seek basic local telecommunications service

authority herein, and thus these sections do not appear to apply. However, if for some reason the Commission will not process this application without reference to these sections, it may consider them referenced.

3. Counsel regrets any inconvenience caused by these omissions.

WHEREFORE, with the above referenced additions to New Edge's Application, New Edge respectfully requests the Commission issue Certificate of Service Authority, competitive status, and waiver of rules and statutes as referenced in the Application.
