Enclosed for filing with the Missouri Public Service Commission ("Commission") on behalf of Confluence Rivers Utility Operating Company, Inc., ("Confluence Rivers") please find, in electronic format, a new sewer tariff (P.S.C. MO No. 13). The purpose of this filing is to implement the agreements set out in the *Unanimous Agreement Regarding Disposition of Small Utility Company Revenue Increase Request* ("*Unanimous Disposition Agreement*") filed by the parties on February 10, 2020.<sup>1</sup>
