Comes now Villa Park Heights Water Company (Applicant),
pursuant to section 393.170, RSMo 1978, and states as follows:

1. That Applicant is a Missouri corporation duly organized
and existing under the laws of the State of Missouri with its
principal office and place of business located at Route 4, Box
883, Springfield, Missouri 65802. It is a public utility under
the jurisdiction of the Missouri Public Service Commission and
presently provides water and sewer service in an unincorporated
area of Greene County, Missouri to approximately 550 water
customers and 55 sewer customers. A certified copy of its
Articles of Incorporation and amendments thereto are attached
hereto, incorporated herein by reference and marked as Exhibit 1.
A certified copy of a certificate of corporate good standing is
attached hereto, incorporated herein by reference and marked as
Exhibit 2.

3. That residents located adjacent to but outside of Applicant's certificated area have contacted Applicant and requested water service from Applicant. That Applicant has the means to provide adequate water service to said residents upon approval of the Commission of an expansion of its certificated area to include the area in which those residents requesting service are located.

4. That attached hereto and incorporated herein by reference as Exhibit 3 is a metes and bounds description of the area sought to be certificated.

5. That attached hereto and incorporated herein by reference as Exhibit 4 is a plat map of the area sought to be certificated.

6. That attached hereto and incorporated herein by reference as Exhibit 5 is a feasibility study containing plans and specifications for the installation and estimated cost thereof during the first three years of construction; plans for financing, proposed rates and charges; and an estimate of the number of customers, revenues and expenses during the first three years of operation in the added area.

7. That the Applicant is in the process of obtaining a franchise from the City of Willard for that part of the area sought to be certificated which is within the boundaries of the City of Willard.

8. That no central water supply service, regulated or non-regulated, is available in the area described in Exhibit 3.

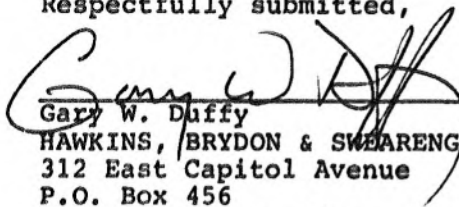
9. That attached hereto and incorporated herein by reference as Exhibit 6 are the names and addresses of persons residing in the proposed service area who have requested service from Applicant.

10. That the granting of the application as requested will serve the public convenience and necessity because it will provide a source of approved water which is not presently

available to these residents, and will thereby allow certain of them to abandon private water wells and avoid the proliferation of new wells in this area which is expanding in population.

WHEREFORE, Applicant requests the Commission to grant it permission, approval, and a certificate of convenience and necessity authorizing it to install, acquire, build, construct, own, operate, control, manage, and maintain a water system for the public within the area referred to in paragraph 4 hereof and for such other orders as the Commission may deem meet and proper.

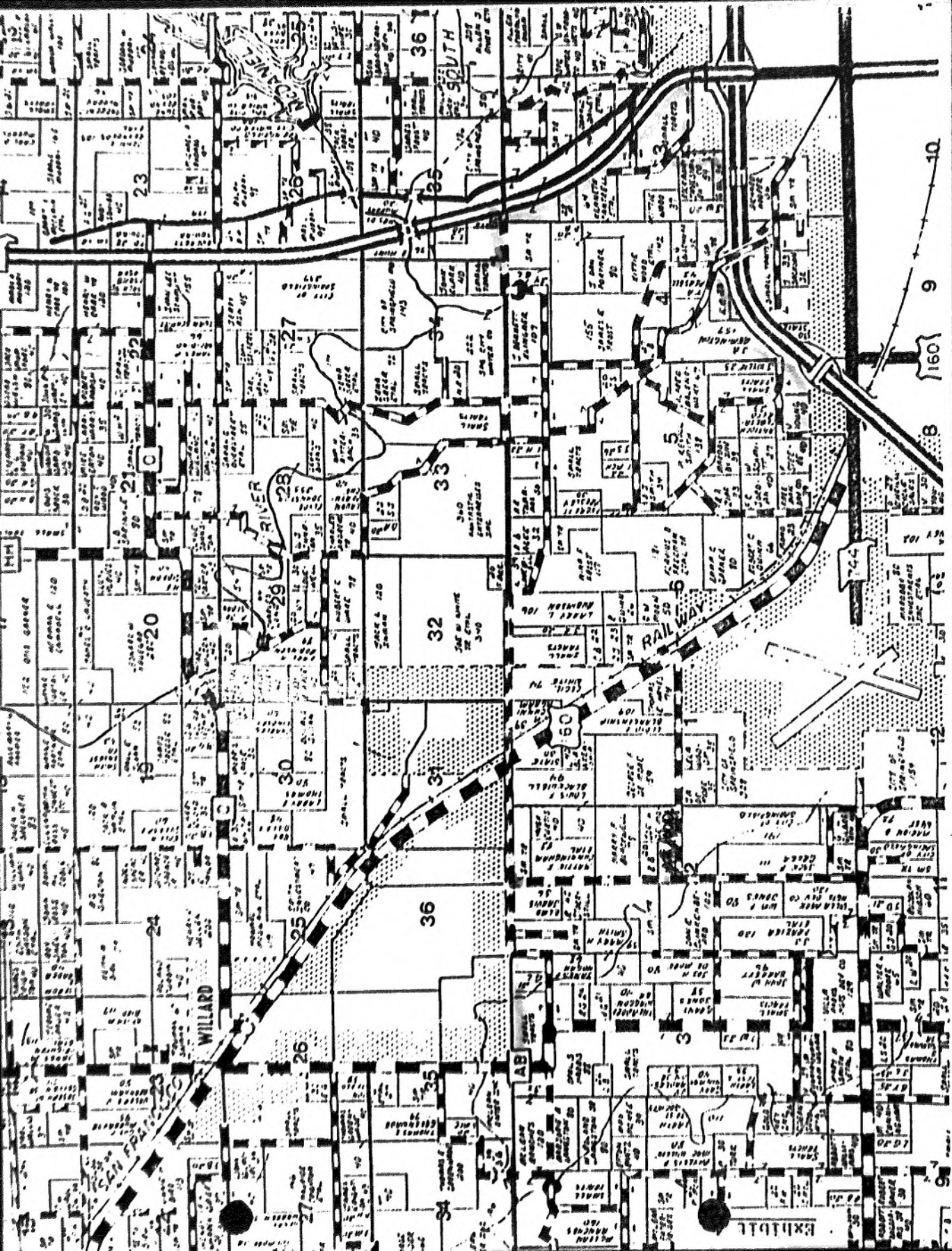
Description of Area Sought to Be Certificated

The east one half of Section Two (2) and all of the north one half of Section One (1) in Township 29 North, Range 23 West;

All of sections Three (3), Four (4), Five (5) and Six (6) in Township 29 North, Range 22 West lying north and east of the centerline of U.S. Highway 160, north of the centerline of Interstate Highway 44, west of Missouri Highway 13, and north of the present corporate limits of the City of Springfield in Greene County, Missouri;

All of Sections Thirty Three (33) and Thirty Four (34) in Township 30 North, Range 22 West in Greene County, Missouri; and the south two hundred (200) feet of Townships Thirty One (31) and Thirty Two (32) in Township 30 North, Range 22 West;

The south 200 feet of Section 36 in Township 30, Range 23 West and the south 200 feet of section 35 in Township 30, Range 23 West which is west of the centerline of County Road AB and within the corporate limits of the City of Willard, Missouri as it presently exists.

FEASIBILITY STUDY

I. INTRODUCTION

A. Purpose of the Study

Villa Park Heights Water Company currently holds a certificate of public convenience and necessity to provide water service in an unincorporated area of Greene County, Missouri described as follows:

All of sections three, four, nine, ten, eleven, fourteen, fifteen, and sixteen; the west one half of section two, and all of the east one-fourth mile of the north three fourth's mile of section five, all in Township 29, Range 23, Greene County, Missouri.

In recent weeks, several residents of an area adjacent to but outside of the certificated area have requested that Villa Park Heights Water Company provide water service to them. This study is prepared to examine the feasibility of providing that service, and in compliance with the Commission's rules requiring such a study for an application for a service area. (4 CSR 240-2.060(2)(A)8.)

II. CURRENT CONDITIONS

A. Water Supply

Residents in the area sought to be certificated in this application currently obtain water from private wells only.

B. Population

The current population of the area sought to be certificated is estimated at 800 on the basis of an average of three people per dwelling and 265 dwellings.

III. CONSTRUCTION PLANS

A. General Approach

The company's first project will be approximately two miles of four inch line to serve approximately 35 new customers. This would proceed in an easterly direction along County Road 94 from its intersection with U.S. Highway 160 northwest of Springfield.

B. Construction Costs

A thirty day time table is projected on the initial construction. Estimated total costs for the two mile extension would be approximately \$21,000.

C. Financing

The project will be financed largely by customer contributions as provided for in the tariff. Future extensions in the area sought to be certificated would be on the same basis.
