**PROPOSED PROCEDURAL SCHEDULE**

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE), and for its response to the Missouri Public Service Commission's (Commission) Order Directing Filing, states as follows:

1. On November 27, 2006, Eva Owen of 2711 Twin Valley Road, Troy, Missouri 63379 initiated this proceeding by filing a Complaint against AmerenUE.
2. To date, AmerenUE and Ms. Owen have been unable to resolve their differences.
3. On February 20, 2007, the Commission issued it Order Directing Filing, which ordered the parties to submit a proposed procedural schedule no later than March 9, 2007.
