## STAFF'S RESPONSE TO MOTION FOR EXPEDITED CONSIDERATION

COMES NOW the Staff of the Public Service Commission of the State of Missouri ("Staff") and respectfully states as follows:

- 1. On June 23, 2000, Laclede Gas Company ("Laclede") filed a Verified Application to issue First Mortgage Bonds, Unsecured Debt and Common Stock in an amount not to exceed \$350,000,000 with the Missouri Public Service Commission ("Commission").
- 2. On June 26, 2000, the Commission issued an Order directing Staff to file a Response to a Motion to Expedite by July 6, 2000. This Response was to state whether Staff it could file its Response by August 10, 2000.
- 3. Staff is unable to provide an exact date by which it can respond because its response will be greatly affected by another case currently pending before the Commission. The other

case, EF2000764, is also a financing case and involves similar financial issues. Staff will be able to file a Staff Recommendation within 10 business days following the Commission decision in EF2000764.

WHEREFORE, Staff respectfully submits this Response to the Order Directing Response to Motion to Expedite.
