Enclosed for filing please find the following revised tariff sheets:

P.S.C. MO No. 2, First Revised Sheet 62 Canceling Original Sheet 62.

This sheet is being filed to reduce the Carrier Common Line (terminating) rate. On May 1, 2012, 3LCom submitted a letter in Case No. TT-2012-0317 explaining that (a) 3LCom's intrastate switched access rates currently mirror those of Southwestern Bell Telephone Company d/b/a AT&T-Missouri, (b) 3LCom would promptly file any needed revisions to its intrastate access tariff following a filing by AT&T-Missouri to reduce its intrastate access rates, and (c) 3LCom does not have any revenue of the type requested to be reported for the mandated rate reduction. On May 15, 2012, AT&T-Missouri filed 16<sup>th</sup> Revised Sheet 13 to its intrastate access tariff (P.S.C. Mo. – No. 36), which reduced the Carrier Common Line (terminating) rate to \$0.000292. 3LCom hereby files First revised Sheet 62 to reduce its intrastate Carrier Common Line (terminating) rate to \$0.000292 so that it continues to mirror AT&T-Missouri's intrastate rate. This sheet is filed with an effective date of July 1, 2012.

Also accompanying this tariff filing is a spreadsheet with supporting data verified by the undersigned.
