**AMERENUE'S REPLACEMENT TARIFF FOR COMPLIANCE TARIFF SHEET 42.1
AND MOTION FOR EXPEDITED TREATMENT**

COME NOW Union Electric Company, d/b/a AmerenUE (AmerenUE or Company), and for its *Replacement Tariff for Compliance Tariff Sheet 42.1 and Motion for Expedited Treatment*, states as follows:

1. On March 15, 2007, the Missouri Public Service Commission (Commission) issued its Order Approving Stipulation and Agreement. The Order authorized AmerenUE to file tariffs sheets as agreed to in the Stipulation and Agreement.

2. On March 21, 2007, AmerenUE filed Compliance Tariffs in accordance with the Commission March 15, 2007 Order.

3. On March 27, 2007, AmerenUE submitted a replacement tariff for Sheet 42.1.

4. In order to address concerns expressed at the March 29, 2007, Agenda meeting, AmerenUE is submitting a second replacement tariff for Sheet 42.1.

5. AmerenUE requests the Commission approve the attached tariff along with the previously filed compliance tariffs, on an expedited basis, no later than March 29, 2007, in order to allow the new rates to go into effect on April 1, 2007. Without the expedited approval, the Company is unable to implement the new rates at the earlier date. The April 1, 2007, date was an important part of the negotiation of the Stipulation and Agreement and underlies AmerenUE's acceptance of the final terms of the Stipulation and Agreement.

WHEREFORE, AmerenUE asks the Commission to approve the attached tariff, along with the previously filed compliance tariffs no later than March 29, 2007 so that the new rates may go into effect on April 1, 2007.
