NOTICE AND ORDER SETTING PREHEARING CONFERENCE

On March 23, 2010,¹ the Commission issued a Notice of New Proceeding. The Commission did so in response to a March 15 revised transportation tariff filing by Missouri Gas Energy, a division of Southern Union Company (hereafter “MGE”), and a Motion to Create New Docket and Set Prehearing Conference filed by Constellation NewEnergy-Gas Division, LLC (hereafter “Constellation”).

The Commission will incorporate the above-referenced pleadings into this file, and set a prehearing conference. Per a Partial Stipulation and Agreement filed in File No. GR-2009-0388, and approved by the Commission, all parties in File No. GR-2009-0355 are automatically parties in File No. GT-2010-0261, and need not apply for intervention.

THE COMMISSION ORDERS THAT:

1. All parties in File No. GR-2009-0355 are parties to this case, and need not apply for intervention.

A prehearing conference is hereby scheduled for this case on April 7, 2010, at 10:00 a.m. The conference shall be held in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. The Governor Office Building meets accessibility standards required by the Americans with Disabilities Act. 4. The parties shall file a proposed procedural schedule on or before April 14, 2010.

5. The Data Center of the Missouri Public Service Commission shall serve a copy of this order upon the county commission of each county affected by the tariff filing as pled by Missouri Gas Energy, a division of Southern Union Company.

6. The Data Center of the Missouri Public Service Commission shall include all parties in File No. GR-2009-0355 as parties to this case, and shall update its service list accordingly.

7. The Commission's Public Information Office shall make notice of this order available to the members of the General Assembly representing the residents of the service area affected by the tariff filing as pled by Missouri Gas Energy, a division of Southern Union Company, and to the news media serving the residents of the counties affected by the tariff filing as pled by Missouri Gas Energy, a division of Southern Union Company.

8. Tariff No. JG-2010-0565, and the Constellation Motion to Create New Docket and Set Prehearing Conference shall be removed from File No. GR-2009-0355, and placed into File No. GT-2010-0261.

9. This order shall become effective upon issuance.
