**RESPONSE OF OSAGE VALLEY ELECTRIC COOPERATIVE TO APPLICATION OF  
BRIAN SHROCK FOR CHANGE OF ELECTRIC SUPPLIER**

COMES NOW Osage Valley Electric Cooperative (“Cooperative”) by and through its undersigned counsel, and for its response to the Application of Brian Shrock (“Applicant”) for Change of Electric Supplier from the City of Butler, Missouri Municipal Electric Utility (“City”) to Osage Valley Electric Cooperative (“Application”), respectfully states as follows:

1. As to Paragraphs 5 and 6 of the Application, Cooperative recently became aware that City was serving addresses that are outside of the corporate boundaries of the City when City approached Cooperative to enter into a Territorial Agreement to rectify this issue as allowed by Section 394.312(2), RSMo. City and Cooperative have entered into a Territorial Agreement, Case No. EO-2023-0126, that Cooperative believes will alleviate the complaints referenced in the Application regarding the inability of the City to connect any new services in this area.
2. Cooperative is without information to confirm or deny all remaining allegations of the Application.
3. Cooperative takes no position on the sufficiency of Applicant’s application for satisfaction of the statutory standard for approval of a change of electric supplier.

4. Cooperative affirms that if the Application is approved, Cooperative has sufficient ability to become Applicant's electric supplier. However, Cooperative would need to construct a 2400-foot line extension and conduct significant tree clearing which would be very costly.
5. Cooperative requests the PSC deny this Application for Change of Electric Supplier as it believes Applicant's grievances will be remedied with approval of the Territorial Agreement referenced in Paragraph 1.
