AMERENUE RESPONSE TO COMMISSION ORDER APPROVING TARIFF AND DIRECTING RESPONSE

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE or the Company) and for its *Response to Commission Order Approving Tariff and Directing Response*, states as follows:

- 1. On August 28, 2009, AmerenUE filed its *Notification of Decision Not to Revise Industrial Demand Response Program*. On September 15, 2009, AmerenUE filed revised tariff sheets (YE-2010-0198) reflecting the same.
- 2. On October 6, 2009, Staff filed its *Recommendation to Approve Tariff Sheets*. On the same date, the Office of Public Counsel (OPC) filed its *Response to Order Directing Staff to File Recommendation* (OPC Response).
- 3. OPC's Response stated that there was an outstanding item from the previously approved tariff sheets for this program, that being the Pilot Program Evaluation. OPC asked that the Missouri Public Service Commission (Commission) order AmerenUE to conduct and file the required evaluation.
- 4. AmerenUE has already conducted the required evaluation, having completed the evaluation approximately a year ago. OPC would not have been aware of that fact as the results had not been shared with the stakeholders. Concurrent with the filing of this pleading, AmerenUE is correcting that oversight by providing the evaluation to all parties to this case. AmerenUE would point out that the tariff does not require the

Company to file the evaluation in the case. Accordingly, AmerenUE believes it is already in full compliance with the requirements of its tariff and that no further action should be required.

WHEREFORE, for the above stated reasons, AmerenUE asks the Commission to accept this pleading in compliance with the Commission's October 14, 2009, Order.
