**SOUTHWESTERN BELL TELEPHONE, L.P., D/B/A SBC MISSOURI'S**  
**RESPONSE TO INTERMEDIA COMMUNICATIONS, INC.'S**  
**MOTION TO DISMISS**

Comes now Southwestern Bell Telephone, L.P., d/b/a SBC Missouri ("SBC Missouri") and, for its Response to Intermedia Communications, Inc.'s ("Intermedia") Motion to Dismiss, states as follows:

1. On January 11, 2005, Intermedia filed a Motion to Dismiss in the above-captioned matter. In its Motion, Intermedia argues that as a result of: "Intermedia's merger into MCImetro, interconnection matters would be governed by the existing

SBC/MCI metro interconnection agreement.”<sup>1</sup> Thus, “SBC’s instant proceeding to amend the interconnection agreement [as to Intermedia] has become moot as to Intermedia and upon the Commission’s Final Order in Case No. TM-2005-0129 becoming effective on January 14, 2005, Intermedia should be dismissed as a party to these proceedings.”<sup>2</sup>

2. SBC Missouri has no objection to Intermedia’s Motion requesting that it be dismissed from the above-captioned proceeding because, since Intermedia ceases to exist, SBC Missouri’s interconnection agreement with Intermedia is effectively terminated and no longer available to Intermedia or any other competitive local exchange carrier.

Wherefore, SBC Missouri prays the Commission grants Intermedia’s Motion to Dismiss, together with any further and additional relief the Commission deems just and proper.
