ORDER GRANTING MOTION
FOR EXTENSION OF TIME TO FILE REPORT

On September 28, 2000, the Commission's Staff filed a Motion for Extension of Time to File Report. Staff states that it has obtained the information necessary for it to prepared reports on compliance and recommendations regarding the settlement agreements filed and approved in these cases, but that it requires time to prepare the reports due to the press of business and the absence of a key staff member during the week of September 25, 2000. The Staff states that the Office of the Public Counsel and the Company do not have an objection to an extension provided that a comparable extension is provided for their Compliance Status Report and Response respectively.

Staff has requested a two-week extension. The request is reasonable and will be granted.

IT IS THEREFORE ORDERED:

1. That the Commission's Staff shall file its Compliance Status Reports in these cases no later that October 13, 2000.

2. That the Office of the Public Counsel shall file its Compliance Status Reports, if it chooses to do so, no later than October 13, 2000.

3. That the Terre Du Lac Utilities Corporation may file responses to any Compliance Status Reports filed in this case no later than November 10, 2000.

4. That this order shall become effective on October 12, 2000.
