APPLICATION FOR CERTIFICATE OF SERVICE AUTHORITY TO PROVIDE INTEREXCHANGE TELECOMMUNICATIONS SERVICES

Access2Go, Inc. (Applicant) pursuant to Sections 392.410, 392.420, 392.430, and 392.440 RSMO 2000¹, and 4 CSR 240-2.060, files this verified application respectfully requesting that the Missouri Public Service Commission (Commission) issue an order that:

- (a) grants Applicant a Certificate of Service Authority to provide interexchange telecommunications services pursuant to Chapter 392 of the Missouri Revised Statutes.
- (b) grants competitive status to Applicant.
- (c) waives certain Commission rules and statutory provisions pursuant to Section 392.420 RSMo, 2000.

In support of its request, Applicant states:

1. Applicant is a corporation duly organized and existing under and by virtue of the laws of the state of Illinois with authority to do business in the state of Missouri. A copy of the Articles of Incorporation issued by the State of Illinois, and the Certificate of Authority from the Missouri Secretary of State to transact business in Missouri are attached hereto as Exhibit I. Applicant proposes to provide interexchange telecommunications services throughout the state of Missouri and therefore seeks statewide authority. A complete description of Applicant's services is described on Exhibit II, which is attached hereto and incorporated herein by reference. Applicant intends to offer such services by reselling services obtained from existing certificated telecommunications providers or by and through its own facilities when they are available. Service will be available 24 hours a day, seven days a week, where facilities permit.

to:

- 3. Applicant has the technical and managerial expertise to provide intrastate toll services within the State of Missouri. Key Personnel Biographies of Applicant's directors are provided in Exhibit III, which is attached hereto and incorporated herein by reference. Applicant is in the process of filing for intrastate long distance authority throughout the United States. Applicant has not been denied authorization by any state.
- 4. Applicant has the financial soundness and ability to provide interexchange telecommunications services in the State of Missouri. Copies of Applicant's most recent financial statements are available upon request.
- 5. Applicant's proposed tariff is attached as Exhibit IV. The proposed tariff, which has a 45-day effective date, contains the rules and regulations applicable to its customers, a description of the services offered, and a list of rates associated with such services.
- 6. Applicant has no pending action or final unsatisfied judgment or decision against it from any state or federal agency or court which involves customer service or rates within the past three (3) years.
 - 7. Applicant hereby certifies that it has no overdue annual reports or assessment fees.
- 8. Applicant believes that granting the requested certificate is in the public interest for the following reasons:
 - a. Applicant's proposed intrastate telecommunications services are developed to serve the long distance needs of subscribers who can not otherwise realize similar cost savings through major carriers.
 - b. An increase in the traffic generated through provision of Applicant's proposed intrastate services over existing major carriers' communications facilities will improve the efficiency and reduce major carriers' costs in provision of these services.

- c. The public will benefit from greater consumer choice created through the broadening of innovative telecommunications service alternatives and ongoing affordable rates maintained by the additional competitive pressure placed on other competitors.
- d. Local Exchange Carriers will realize greater access charge revenues through the increase in traffic utilizing local access.
- 9. Applicant requests classification as a competitive telecommunications company within the State of Missouri. Applicant believes that its proposed services will be subject to sufficient competition to justify a lesser degree of regulation. Granting of this application will allow greater price and service options for telecommunication users.
- 10. Applicant also requests, pursuant to Section 392.420, that the Commission waive the application of the following rules and statutory provisions as they relate to the regulation of Applicant:

11. The above statutes and regulations have been waived previously for other applicants seeking certification as competitive interexchange telecommunications carriers. These rules and statutory provisions are principally designed to apply to non-competitive telecommunications carriers. As a result, it would be inconsistent with the goal and purpose of federal and state statutes to apply these rules and statutes to a competitive company such as Applicant.

12. Applicant, pursuant to Section 386.570, will comply with all applicable Commission rules except those which are specifically waived by the Commission pursuant to a request filed by the Applicant.

WHEREFORE, Applicant respectfully requests that the Missouri Public Service Commission grant it a certificate of service authority to provide interexchange telecommunications services within the State of Missouri. Applicant also requests classification as a competitive telecommunications company. In addition Applicant requests a waiver of the above-referenced rules and statutory provisions.

Inbound Dedicated Service

Access2Go, Inc. Inbound Dedicated Service receives inbound Intrastate calls on Dedicated Access Lines using 800 or 888 number(s).

Outbound Dedicated Service

Access2Go, Inc. Outbound Dedicated Service sends outbound intrastate calls on Dedicated Access Lines by dialing "1+ ten digits" for interLATA.

Switched Access Services

Access2Go, Inc. Switched Access Service allows a customer to access the Company's long distance network via FGD access.

Inbound Switched Service

Access2Go, Inc. Inbound Switched Service receive inbound Intrastate calls on Switched Access Lines using 800 or 888 number(s).

Outbound Switched Service

Access2Go, Inc. Outbound Switched Service sends outbound Intrastate calls on Switched Access Lines by dialing "1+ ten digits" for interLATA calls.

Private Line Services

Mr. Shefts started his career in the telecommunications industry with Ameritech Services in 1989. He worked in a technical ops group for two years while he was working towards his MBA.

In 1992 Mr. Shefts entered sales with Ameritech by opening a sales office for them in Peoria, IL From 1992-1997 Mr. Shefts earned "The President's Club" for outstanding sales achievement and in 1995 was awarded "Salesman of the Year".

In 1997 Mr. Shefts left Ameritech to go into his own business as a telecommunications consultant.

In 1999 Mr. Shefts set up his own Ameritech distributorship (Data-Tel Solutions which later became The Broadband Shop, Inc.).
