ORDER DIRECTING FILING

On September 15, 2003, Mister Jeff's Hair Center applied for a certificate of service authority to provide private pay telephone service in the state of Missouri. Mister Jeff's claims to be an individual doing business under own name. The application also says that the Applicant's name is Jeffry L. Faulkner, and contains the apparent signature of Jeffry Faulkner. The accompanying affidavit states that Mister Jeff's Hair Center of Jeffry L. Faulkner is the Applicant.

The Commission is unclear who the Applicant is. If Mister Jeff's Hair Center is the Applicant, and Mister Jeff's is a corporation or partnership, then a member of the Missouri Bar must file the application on Mister Jeff's behalf. **if Jeffry L. Faulkner is the Applicant, d/b/a Mister Jeff's Hair Center, then the Application must include a copy of the fictitious business name's registration with the Secretary of State.** If Jeffry L. Faulkner is the Applicant as an individual doing business under his own name, then the Application must state that Jeffry L. Faulkner is the Applicant, and not Mister Jeff's Hair Center.
