# APPLICATION TO INTERVENE OF PLATTE COUNTY REGIONAL SEWER DISTRICT

COMES NOW the Platte County Regional Sewer District ("PCRSD" or "District"), a political subdivision, pursuant to Missouri Public Service Commission ("Commission") Rule 4 CSR 240-2.075 and the Commission's *Notice of Application, and Order Setting Deadline for Intervention and Directing Staff to File Recommendation* issued in this matter on August 24, 2009, and respectfully applies to intervene in the above-captioned proceeding. In support of its application, PCRSD respectfully states:

- 1. The Platte County Regional Sewer District is a common sewer district organized and existing pursuant to the provisions of Chapter 204, RSMo. The District was incorporated by the Circuit Court of Platte County, Missouri by its Order of April 15, 1992.
- 2. PCRSD was organized, incorporated and specifically authorized to provide sanitary sewer collection and treatment services to the entire unincorporated area of Platte County, Missouri.

- 5. PCRSD does not have any pending actions or final unsatisfied judgments or decisions against it as contemplated by 4 CSR 240-2.060(1)(K), nor does PCRSD have any annual reports or assessment fees that are overdue.
- 6. On August 24, 2009, Timber Creek filed an Application with the Missouri Public Service Commission to further extend its authorized service area for providing sanitary sewer service in Platte County, Missouri into certain unincorporated areas of Platte County, Missouri.
- 7. The area designated by Timber Creek in its Application is presently under the jurisdiction of the Platte County Regional Sewer District and the District opposes any further extension of the service area of Timber Creek into the Platte County Regional Sewer District's jurisdictional area. Accordingly, PCRSD opposes the relief sought in Timber Creek's Application.

- 8. As shown above, PCRSD has an interest in this proceeding which is different from that of the general public and which may be adversely affected by a final order arising from this case. Furthermore, PCRSD's expertise in this area will assist the Commission in resolving this matter and its intervention will serve the public interest.
  - 9. No other party to this proceeding can adequately represent PCRSD's interests.

**WHEREFORE**, the Platte County Regional Sewer District respectfully requests the Commission to grant its application to intervene as a party in this matter.
