ORDER APPROVING TARIFF

On April 15, 1994, International Telemanagement Group, Inc. (ITG or company) made application with the Missouri Public Service Commission (Commission) for a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri. On July 22, 1994, the Commission granted ITG's application and directed the company to file its tariff within thirty (30) days. ITG's certificate of authority becomes effective upon the approval of its tariff by the Commission.

ITG filed its proposed tariff on September 19, 1994, reflecting the rates, rules, and regulations it intends to use for providing services in Missouri, and carrying an effective date of October 28, 1994. The tariff also reflects its status as a competitive telecommunications provider, and indicates the statutory and regulatory requirements waived by the Commission pursuant to Section 392.420, RSMo Supp. 1993. ITG is proposing to provide switched interexchange services including "1+" long distance, calling card, and debit card services, primarily to business customers. ITG filed substitute sheets to amend its proposed tariff on October 13 and 20, 1994.

On October 20, 1994, the Staff of the Missouri Public Service Commission (Staff) filed a memorandum giving its recommendation. Staff stated that it had reviewed the proposed tariff and substitute sheets and concluded that it clearly and comprehensively describes the terms and conditions of the services to be offered, and that those services are within the scope of the certificate of authority conditionally granted. Staff concluded that the proposed tariff is consistent with service offerings currently available from other interexchange carriers and approved by the Commission, is in compliance with Commission rules and regulations, and recommended that the tariff, as amended, be approved for services on and after October 28, 1994.

Having reviewed ITG's tariff and Staff's recommendation, the Commission finds that ITG's proposed tariff, as amended, details the services, equipment, and pricing it proposes to offer, and that the proposed tariff is similar to those which have been approved for other Missouri certificated interexchange carriers providing similar services. The Commission further finds that the proposed tariff filed on September 19, 1994, complies with the Commission's order and should be approved, as amended, for services on and after October 28, 1994.

IT IS THEREFORE ORDERED:

1. That the tariff filed by International Telemanagement Group, Inc. on September 19, 1994, is hereby approved, as amended, for services on and after October 28, 1994. The tariff approved is:

P.S.C. Mo. No. 1.

2. That this order shall become effective on the 28th day of October, 1994.
