ORDER APPROVING TARIFF

On February 8, 1995, the Commission issued a Report And Order in this case which authorized Capital City Water Company (Company) to file tariff sheets designed to increase gross annual revenues in the amount of \$334,799 exclusive of gross receipts and franchise taxes. On February 17, 1995, the Company filed tariff sheets as authorized by the Commission in its Report And Order issued in this case. On February 21, 1995, the Company withdrew tariff sheet P.S.C. Mo. No. 3, Original Sheet No. 5-A.

On February 21, 1995, the Staff filed a memorandum to the official case file regarding the tariffs. Staff states that it has reviewed the tariff sheets and finds them to be in compliance with the Commission's Report And Order issued in this case, and recommends that they be approved for water service rendered on and after February 22, 1995. Staff states that this filing will have no effect on any other matters for Capital City Water Company that may be pending before the Commission at this time.

The Commission has reviewed the tariff sheets filed by the Company and the Staff's memorandum. The Commission finds that the tariff sheets filed by the Company on February 17, 1995, with the exception of P.S.C. Mo. No. 3, Original Sheet No. 5-A, are in compliance with the Commission's order and should be approved for service on and after February 22, 1995.

IT IS THEREFORE ORDERED:

1. That the following tariff sheets filed by Capital City Water Company are hereby approved for service on and after February 22, 1995:
