ORDER APPROVING TARIFF SHEETS

By its Order Approving Stipulation and Agreement issued in these cases on June 23, 1987, this Commission authorized Continental Telephone Company of Missouri and Contel Systems of Missouri, Inc., to file revised tariffs designed to decrease Missouri jurisdictional gross annual revenues by \$2,506,294 and \$660,620 respectively, exclusive of license, occupations, franchise, sales, gross receipts or similar fees or taxes. The Order directed that the revised tariffs shall hear an effective date of July 1, 1987.

In conformance with the Order of the Commission, Continental Telephone Company of Missouri and Contel Systems of Missouri, Inc., on June 24, 1987, submitted for Commission approval, revised tariff sheets containing rates designed to comply with the Commission's Order with a requested effective date of July 1, 1987.

The Commission is of the opinion the proposed tariff sheets submitted on June 24, 1987, comply with its Order Approving Stipulation and Agreement, and said tariff sheets should be allowed to become effective on July 1, 1987.

ORDERED: 1. That the following tariff sheets submitted on June 24, 1987, by Continental Telephone Company of Missouri, containing rates designed to decrease its Missouri jurisdictional gross annual revenues by approximately \$2,506,294, exclusive of license, occupation, franchise, sales, gross receipts and other similar fees or taxes be, and the same are, hereby approved for telephone service rendered on and after July 1, 1987.
