

ORDER APPROVING CORRECTED TARIFF SHEET

By its Order Approving Stipulation and Agreement dated May 20, 1987 in these cases, this Commission authorized Laclede Gas Company to file revised tariffs designed to decrease jurisdictional gross annual gas revenues by \$7 million exclusive of applicable license, occupation, franchise, gross receipts or other similar fees or taxes.

On May 22, 1987, Laclede Gas Company submitted revised tariff sheets for Commission review and approval, to comply with the Commission's May 20, 1987, Order.

On June 25, 1987, Laclede Gas Company submitted a revised tariff sheet to correct an inadvertent clerical omission from one of the tariff sheets filed on May 22, 1987.

Based on Staff's recommendation, the Commission is of the opinion that for good cause shown the corrected tariff sheet submitted June 25, 1987, should be allowed to become effective for service rendered on and after July 1, 1987.

It is, therefore,

ORDERED: 1. That the following tariff sheet submitted June 25, 1987, by Laclede Gas Company for the purpose of correcting a tariff filed May 22, 1987, which contained an inadvertent clerical omission, be, and it is, hereby approved and made effective for service rendered on and after July 1, 1987.


