## **ORDER APPROVING TARIFF**

By order issued on November 18, 1999, the Commission granted to Adelphia Business Solutions Operations, Inc. (Adelphia) certificate of service authority to provide basic local telecommunications services in Missouri. Adelphia filed a basic local service tariff on March 2, 2000, with an effective date of April 17. Adelphia subsequently extended the effective date of the tariff to May 19, May 31, June 16, and finally June 30. Adelphia filed substitute tariff sheets on April 10, April 26, April 28, May 10, May 22, May 30 and June 5. The Commission's Staff reviewed the tariff sheets and filed a Staff Recommendation and Memorandum on June 7, recommending that the Commission approve them as amended by the substitute sheets.

The Commission has reviewed the tariff sheets and Staff's recommendation and finds that the tariff sheets, as amended, conform to the Commission's Order of November 18, and should be approved to become effective on June 30, 2000. The certificate of service authority granted to Adelphia to provide basic local telecommunications services shall become effective on June 30.

#### **IT IS THEREFORE ORDERED:**

1. That the tariff filed by Adelphia Business Solutions Operations, Inc. on March 2, 2000, and assigned tariff number 200000792, is approved as amended to become effective on June 30, 2000. The tariff approved is:
