# ORDER DIRECTING FILING

Pursuant to the Commission's Arbitration Order issued and effective March 23, 2000, Southwestern Bell Telephone Company (SWBT) was directed to file confidential quarterly monitoring reports with the Commission concerning the provisioning and conditioning of loops for xDSL services. Ordered paragraph 5 stated:

That Southwestern Bell Telephone Company shall provide the Commission with confidential quarterly monitoring reports beginning July 1, 2000, showing the total number of loops requested for xDSL services and the number of loops requested for xDSL based services and the number of loops requested that required conditioning by binder group and each affiliate or company requiring these loops or services.

In an Order Directing Filing issued on July 7, 2000, the Commission further directed that monitoring reports provide the number of wholesale loops requested per company or affiliate.

SWBT filed monitoring reports on July 5, 2000, and October 10, 2000, and a supplemental report on July 26, 2000. SWBT noted in its July 26 and October 10 reports that SBC Advanced Solutions, Inc., provided xDSL service through a line-sharing arrangement and thus did not "order any wholesale loops."

The purpose of the Commission's request for monitoring reports would be served by including loops requested or provided for xDSL services

through line-sharing arrangements. SWBT will be directed to supplement its prior and future reports by providing this same information related to line-sharing arrangements.

### IT IS THEREFORE ORDERED:

- 1. That Southwestern Bell Telephone Company shall supplement its prior monitoring reports and subsequent reports to include information for loops that that were requested or provided through line-sharing arrangements to show the total number of loops requested for xDSL-based services and the number of such loops that required conditioning by binder group for each affiliate or non-affiliate company.
- 2. That supplemental monitoring reports that are due under this order shall be filed within 30 days of the issue date of this order.
  - 3. That this order shall become effective on November 9, 2000.
