ORDER DIRECTING FILING

GTE Midwest Incorporated and GTE Arkansas Incorporated (GTE) filed an Application with the Missouri Public Service Commission (Commission) on November 18, 1999, for approval of an interconnection agreement with Delta Phones, Inc. under the provisions of the Federal Telecommunications Act of 1996.

Commission Rule 4 CSR 240-2.060(1)(A) requires all applications to the Commission to include " . . . street and mailing address of the principal office or place of business of applicant." GTE did not include the street and mailing address of the principal office or place of business of the applicants in its application as required by Commission Rule 4 CSR 240-2.060(1)(A).

Commission Rule 4 CSR 240-2.060(1)(B) requires all applications to the Commission to include "A brief statement of the character of business performed by each applicant." GTE did not include a brief

statement of the character of the business performed by each applicant in its application as required by Commission Rule 4 CSR 240-2.060(1)(B).

IT IS THEREFORE ORDERED:

1. That GTE Midwest Incorporated and GTE Arkansas Incorporated shall file the street and mailing address of the principal office or place of business of the applicants as required by Commission Rule 4 CSR 240-2.060(A) no later than 3:00 p.m. on December 10, 1999.

2. That GTE Midwest Incorporated and GTE Arkansas Incorporated shall file a brief statement of the character of the business performed by each applicant as required by Commission Rule 4 CSR 240-2.060(1)(B) no later than 3:00 p.m. on December 10, 1999.

3. That this order shall become effective on December 10, 1999.
