- 1. That GTE Midwest Incorporated and GTE Arkansas Incorporated shall file the street and mailing address of the principal office or place of business of the applicants as required by Commission Rule 4 CSR 240-2.060(A) no later than 3:00 p.m. on December 10, 1999.
- 2. That GTE Midwest Incorporated and GTE Arkansas Incorporated shall file a brief statement of the character of the business performed by each applicant as required by Commission Rule 4 CSR 240-2.060(1)(B) no later than 3:00 p.m. on December 10, 1999.
 - 3. That this order shall become effective on December 10, 1999.
