ORDER RECOGNIZING FICTITIOUS NAME
AND APPROVING TARIFF

ASC Telecom, Inc. (ASC), submitted revised tariff sheets on January 28, 2000, designed to reflect that it will be operating under the fictitious name, AlternaTel. ASC included with its filing a Registration of Fictitious Name from the Missouri Secretary of State. ASC's tariff has an effective date of February 27, 2000. Substitute sheets were filed on February 3, 2000.

The Staff of the Missouri Public Service Commission (Staff) filed a recommendation on February 8, 2000, stating that it had reviewed the company's tariff and recommended approval of the name change and that the Commission allow the proposed tariff sheets, as amended, to go into effect. Staff stated in its recommendation that in addition to the inclusion of a fictitious name, the tariff sheets attempt to clarify the discontinuance of service provisions by stating "that the carrier may discontinue or cancel service according to Commission rules."

The Commission has reviewed ASC's tariff filing, the substitute tariff sheets, and Staff's recommendation, and finds that the addition of a fictitious name should be recognized. The Commis-

sion further finds that the tariff sheets reflecting that fictitious name should be approved.

IT IS THEREFORE ORDERED:

1. That the addition of the fictitious name of "ASC Telecom, Inc. d/b/a AlternaTel" is recognized.

2. That the tariff sheets filed by ASC Telecom, Inc., on January 28, 2000, and amended on February 3, 2000, Tariff File No. 200000665, are approved as amended for service on and after February 27, 2000. The tariff sheets approved are:

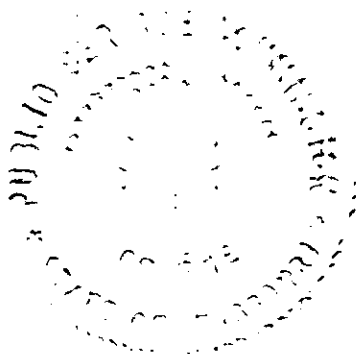
