ORDER ACKNOWLEDGING CHANGE OF NAME AND APPROVING TARIFF

Avant-Garde Telecommunications of Missouri, Inc. (AGT or the company) was certificated to provide interexchange telecommunications services in the state of Missouri effective April 26, 1995, in Case No. TA-95-268. AGT advised the Commission on September 19, 1995, that because of a merger between its parent corporation and a subsidiary of WinStar Communications, Inc. (WCI), AGT is now wholly owned by WCI. Accordingly, AGT has changed its name to WinStar Wireless of Missouri, Inc., and the company will operate in Missouri under this name. AGT filed tariff sheets on September 19, 1995, reflecting the change in corporate name and revising its tariff to include additional 38 Ghz rates and service descriptions, and to make changes regarding Carrier Liability, and its Interruption and Service Allowance. The company filed substitute sheets on October 11, 1995.

The Staff of the Missouri Public Service Commission filed a memorandum giving its recommendation on October 13, 1995. Staff stated that it had reviewed the proposed tariff sheets and has no objection to approval of the tariff sheets as amended. Staff recommended that the tariff sheets be approved as amended to go into effect on October 19, 1995.

Having reviewed the company's tariff sheets and Staff's recommendation, the Commission finds that the company's tariff, as amended reflects its new corporate name, and accurately reflects its services and

rates. The Commission further finds that the proposed tariff filed on September 19, 1995, should be approved as amended to become effective on October 19, 1995.

IT IS THEREFORE ORDERED:

1. That the tariff sheets filed by WinStar Wireless of Missouri, Inc. on September 19, 1995, are approved as amended to become effective on October 19, 1995. The tariff sheets approved are:
