ORDER AND NOTICE

On November 2, 1999, Atmos Energy Corporation (Atmos) and Arkansas Western Gas Company, d/b/a Associated Natural Gas Company (ANG), filed a joint application with the Commission for authority for ANG to sell and transfer to Atmos all of the assets of ANG located in Missouri. Atmos also seeks a certificate of public convenience and necessity authorizing it to provide gas service in the service areas currently served by ANG. Atmos currently provides natural gas service in Missouri through its divisions, United Cities Gas Company and Greeley Gas Company. If the proposed sale is approved, Atmos will include the service areas presently served by ANG as a part of its United Cities Gas Company division.

Proper parties should be given notice and an opportunity to intervene in this matter. The Records Department of the Commission shall

send a copy of this order to the mayors of all municipalities and county commissions located within the service areas of ANG, United Cities Gas Company and Greeley Gas Company. The Information Officer of the Commission shall send notice of this application to the members of the General Assembly who represent each county located within the service areas of ANG, United Cities Gas Company and Greeley Gas Company, and to the newspapers that serve each county within the service areas of ANG, United Cities Gas Company and Greeley Gas Company, as listed in the newspaper directory of the current Official Manual of the State of Missouri. In addition, the Records Department of the Commission shall send notice to all gas companies regulated by the Commission.

Proper persons wishing to intervene shall file an application to intervene with the Secretary of the Missouri Public Service Commission. Copies of the application to intervene should be sent to the parties listed below.

The requirement of a hearing has been fulfilled when all those having a desire to be heard are offered an opportunity to be heard. If no proper party is granted intervention and neither the Commission's Staff nor the Office of the Public Counsel requests a hearing, the Commission may determine that a hearing is not necessary and that the Applicant may submit its evidence in support of the application by verified statement. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494, 496 (Mo. App. 1989).

IT IS THEREFORE ORDERED:

- That the Information Office and the Records Department of the Missouri Public Service Commission shall provide notice as set out herein.
