

ORDER AND NOTICE

On May 13, 1999, in Case No. EO-98-413, the Commission issued an order approving Union Electric Company d/b/a AmerenUE's participation in the Midwest Independent System Operator (ISO). On June 11, 2001, AmerenUE filed an application with the Commission requesting authority to withdraw from the Midwest ISO and to join the Alliance Regional Transmission Organization.

Proper parties should be given notice and an opportunity to intervene in this matter. The Records Department of the Commission shall send a copy of this order to all parties to Case No. EO-98-413. Anyone wishing to intervene must submit an application to intervene to:

The requirement for a hearing is met when the opportunity for hearing has been provided and no proper party has requested the opportunity to present evidence.¹ If no one asks permission to intervene or requests a hearing, the Commission may grant the relief requested based on the application.

IT IS THEREFORE ORDERED:

1. That the Records Department of the Missouri Public Service Commission shall provide notice as set out herein.
2. That any interested party wishing to intervene in this case shall file an application to do so as directed herein no later than July 18, 2001.
3. That this order shall become effective on July 8, 2001.

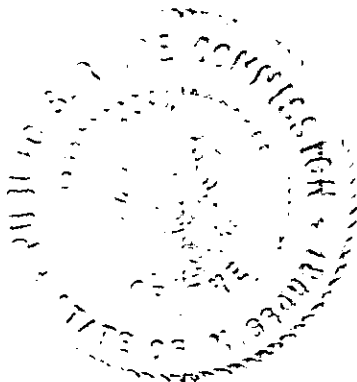
