On December 21, 2000, NeuStar, Inc. (NeuStar), in its role as the North American Numbering Plan Administrator, on behalf of the Missouri telecommunications industry ("Industry"), <sup>1</sup> filed a letter in the above-captioned proceeding with the Missouri Public Service Commission setting forth the Industry's relief implementation plan and schedule for area code relief in the 816 area code. By this letter, NeuStar requests that a typographical error in the attachment to its December 21 letter entitled "Missouri – 816 NPA Initial Implementation Meeting Conference Call" be corrected.
