MOTION FOR EXPEDITED TREATMENT TO APPROVE
BASIC LOCAL SERVICE TARIFF SHEET
ON LESS THAN THIRTY DAYS NOTICE

COMES NOW The Pager Company dba The Pager & Phone Company (PagerCo), by and through counsel and pursuant to 4 CSR 240-2.065 (2) and 4 CSR 240-2.080(16), and files its Motion for Expedited Treatment to Approve Tariff Sheet on Less Than Thirty Days Notice ("Motion"). This Motion is in reference to Tariff File No. JC-2003-1357, and more specifically only applies to MO P.S.C. No. 1, Fourth Revised Page 8, which was filed January 21, 2003 with an effective date of February 21, 2003. PagerCo requests this tariff page be allowed to take effect on February 2, 2003. In support of this Motion, PagerCo respectfully states as follows:

1. On January 21, 2003, PagerCo filed basic local tariff revisions, including MO P.S.C. No. 1, Fourth Revised Page 8. The tariff was filed with a 30-day effective date per Section 392.220 RSMo. The tariff filing was assigned Tariff File JC-2003-1357. PagerCo herein requests that Fourth Revised Page 8 in Tariff File JC-2003-1357 be allowed to take effect on February 2, 2003, or as soon thereafter as the Commission can process and approve the revised tariff sheet.
2. The proposed revision to Fourth Revised Page 8 is to add text to the definition of Administrative Change Charge (ACC) so that the ACC will apply to additional situations


where changes to the customer's service require an order to be placed with the underlying service provider (ILEC), thereby incurring a charge to PagerCo from the ILEC. This additional language is necessary because without it PagerCo will not be able to recover costs related to changes in PagerCo customers' services which must be paid to the ILEC.

3. Today, January 23, 2003, the Commission approved PagerCo's initial interexchange (IXC) service tariff effective February 2, 2003, in Case No. XA-2003-0118. The IXC tariff was filed in compliance with the Commission's Order Approving Interexchange Certificate of Service Authority, issued November 5, 2002, in Case No. XA-2003-0118. Approval of PagerCo's IXC tariff was a necessary corollary to institution of PagerCo's UNE-P based basic local service, called PHONEPLUS. Rates, terms and conditions for PHONEPLUS service were recently added to PagerCo's basic local service tariff in Tariff File JC-2003-1255, effective January 18, 2003. After the PHONEPLUS tariff revisions were approved, PagerCo discovered that the definition of Administrative Change Charge in its basic local tariff was faulty and did not appear to permit recovery of charges that would be incurred by PagerCo from its underlying carrier(s) in certain circumstances. The urgency for approval of the revision to Page 8 is that with today's approval of PagerCo's IXC tariff and the Commission's recent approval of PagerCo's PHONEPLUS service, PagerCo is prepared to roll out its UNE-P based service on and after February 2, but must be able to recover the ACC in order to transfer existing customers from resale-based service to UNE-P service. The harm that will be avoided by allowing this tariff revision to take effect in less than 30 days is that PagerCo will be able to convert current Basic Prepaid Service customers to PHONEPLUS service, which will provide optional features at lower cost to those customers, without unreimbursed costs to PagerCo.

4. This Motion is being filed as soon as possible after the tariff revision was filed and the urgency for implementation of the tariff revision was discovered.

WHEREFORE, PagerCo hereby respectfully requests that the Commission approve MO P.S.C. No. 1, Fourth Revised Page 8, on less than thirty days notice pursuant to 4 CSR 240-2.065(2). PagerCo requests that Fourth Revised Page 8 be approved for service on and after February 2, or as soon thereafter as it is possible for the Commission to review and approve the tariff page.
