ORDER CANCELING CERTIFICATES

Effective Date: June 16, 2006

On May 25, 2006, the Staff of the Commission filed a Motion to Open Case and Cancel Certificates of Service Authority. Staff requested that the Commission cancel the private pay telephone certificates of service authority of St. Joe Inn, Inc., d/b/a Days Inn; T&T Communications, LLC; BNL Communications, Inc.; and Data Tel Communications, LLC.

Staff stated that these providers are no longer entitled to their certificates because each provider submitted a Statement of Revenue for Fiscal Year 2005 that reported no annual revenue, and that stated that the providers do not wish to retain their certificates. Furthermore, Staff stated that it assessed all of the above providers with an estimated assessment of \$0.00, and alleges that each provider owes no assessments, with the exception of BNL, who owes a \$25.95 assessment for FY2001.

Commission Rule 4 CSR 240-2.080(15) gives parties ten days to respond to pleadings. Each provider failed to respond within ten days.

Section 392.410, RSMo 2000, gives the Commission authority over granting certificates of service authority to provide telecommunications services. The Commission

has reviewed Staff's motion and finds that it shall cancel the certificates of service authority that Staff requested the Commission to cancel.

IT IS ORDERED THAT:

1. The Staff of the Commission's Motion to Open Case and Cancel Certificates of Service Authority is granted.
2. The private pay telephone certificate of service authority granted to St. Joe Inn d/b/a Days Inn in Case No. TA-95-310 is canceled.
3. The private pay telephone certificate of service authority granted to T&T Communications, LLC, in Case No. TA-2002-196 is canceled.
4. The private pay telephone certificate of service authority granted to BNL Communications, Inc., in Case No. TA-93-182 is canceled.
5. The private pay telephone certificate of service authority granted to Data Tel Communications, LLC, in Case No. TA-2001-538 is canceled.
6. This order shall become effective on June 16, 2006.
7. This case may be closed on June 17, 2006.
