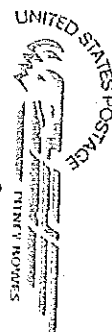
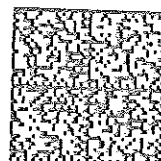

ORDER CANCELING CERTIFICATE

Issue Date: December 22, 2011

Effective Date: December 31, 2011

This order cancels the private pay telephone certificate of AmeriCall, Inc.,
d/b/a Call Solutions, Inc.

On November 29, 2011, the Staff of the Missouri Public Service
Commission filed a motion requesting Call Solutions' certificate to provide private
pay telephone service in the State of Missouri be canceled.

In Case Number TA-2001-18, the Commission granted Call Solutions a
certificate of service authority to provide private pay telephone service in the
State of Missouri via customer-owned coin-operated telephone equipment.

Staff's motion states that in 2002 the Missouri Secretary of State's Office
revoked the Call Solutions' authority to do business in Missouri due to failure to
file a 2001 annual report. Call Solutions has not received reinstatement of its
authority to do business in Missouri. In addition, Call Solutions has not provided
the Commission with a current address and phone number. Call Solutions is
also delinquent in the payment of its 2010 assessment to the Commission. Staff
indicated that to the best of their knowledge, information and belief, Call
Solutions is no longer providing private pay telephone service in Missouri. Staff

recommends that the Commission cancel Call Solutions' certificate of service authority.

On December 1, 2011, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than December 12, 2011. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo (Supp. 2010), which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and because Call Solutions did not object to Staff's motion, the Commission finds that the private payphone certificate granted to AmeriCall, Inc., d/b/a Call Solutions, Inc. shall be canceled.

THE COMMISSION ORDERS THAT:

1. The private payphone certificate granted to AmeriCall, Inc., d/b/a Call Solutions, Inc., in Case Number TA-2001-18, is canceled.
2. This order shall become effective on December 31, 2011.

3. This case may be closed on January 1, 2012.


