ORDER CANCELING CERTIFICATES

Effective Date: October 23, 2005

On September 27, 2005, the Staff of the Commission filed a Motion to Open Case and Cancel Certificates of Service Authority. Staff requested that the Commission cancel the private pay telephone certificates of service authority of Barb Sonnier d/b/a DBS; Golden Tel, Inc.; Kevin E. Thompson; Kevin S. Underwood; Reliable Payphone, Inc.; Robert H. Dolliver, IV; Tension Envelope Corporation; and Wendy Douglas.

Staff stated that these providers are no longer entitled to their certificates because each provider marked on its 2004 Statement of Revenue form that it no longer wishes to have a certificate. Furthermore, Staff alleges that each provider is current on its annual report and owes no assessments.

Commission Rule 4 CSR 240-2.080(15) gives parties 10 days to respond to pleadings. Each provider failed to respond within 10 days.

Section 392.410, RSMo 2000, gives the Commission authority over granting certificates of service authority to provide telecommunications services. The Commission

has reviewed Staff's motion, and finds that it should cancel the certificates of service authority that Staff requested the Commission to cancel.

IT IS THEREFORE ORDERED:

1. That the Staff of the Commission's Motion to Open Case and Cancel Certificates of Service Authority is granted.

2. That the private pay telephone certificate of service authority granted to Barb Sonnier d/b/a DBS in Case No. PA-2005-0092 is canceled.

3. That the private pay telephone certificate of service authority granted to Golden Tel, Inc., in Case No. TA-96-106 is canceled.

4. That the private pay telephone certificate of service authority granted to Kevin E. Thompson in Case No. TA-97-233 is canceled.

5. That the private pay telephone certificate of service authority granted to Kevin S. Underwood in Case No. PA-2003-0316 is canceled.

6. That the private pay telephone certificate of service authority granted to Reliable Payphone, Inc., in Case No. TA-94-314 is canceled.

7. That the private pay telephone certificate of service authority granted to Robert H. Dolliver, IV, in Case No. TA-97-165 is canceled.

8. That the private pay telephone certificate of service authority granted to Tension Envelope Corporation in Case No. TA-95-53 is canceled.

9. That the private pay telephone certificate of service authority granted to Wendy Douglas in Case No. PA-2003-0049 is canceled.

10. That this order shall become effective on October 23, 2005.

11. That this case may be closed on October 24, 2005.
