MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY

COMES NOW the Staff of the Missouri Public Service Commission and moves for the Missouri Public Service Commission (Commission) to cancel the certificate of payphone service authority in Missouri of Innovative Businesses and Services, Inc. ("the Company) and states as follows:

- 1. On August 28, 1996, the Commission granted a certificate of payphone service authority to the Company in Case No. TA-97-37.
- 2. On July 28, 2014, the Staff's attempt to contact the Company was returned by the Postal Service (see attachment). The Company failed to file an annual report or pay any assessment to the Commission. The Staff believes that the Company no longer provides telecommunications services in Missouri.
- 3. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5 RSMo 2000, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."
- 4. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. W.D. 1989).

WHEREFORE, the Staff respectfully recommends the Commission cancel the certificate of service authority of Innovative Businesses and Services, Inc. to provide payphone telecommunications service in Missouri.
