ORDER CANCELING CERTIFICATE

Issue Date: May 21, 2018 Effective Date: June 20, 2018

This order cancels the private pay telephone certificate of Roaming Contact, LLC.

On May 2, 2018, the Staff of the Missouri Public Service Commission filed a motion requesting Roaming Contact, LLC's certificate to provide private pay telephone service in the State of Missouri be canceled.

In File Number PA-2013-0479, the Commission granted Roaming Contact, LLC a certificate of service authority to provide private pay telephone service in the State of Missouri via customer-owned coin-operated telephone equipment.

Staff's motion states that the company requested cancellation of its certificate of service authority. Staff recommends that the Commission cancel Roaming Contact, LLC's certificate of service authority as the company is no longer providing service in Missouri.

On May 3, 2018, the Commission issued an Order Establishing Time to Respond to Motion allowing anyone to file a response or request a hearing to do so no later than May 14, 2018. No responses were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo 2016 which states, in part, "[a]ny certificate

or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Roaming Contact, LLC's request and Staff's motion, the Commission finds that the private payphone certificate granted to Roaming Contact, LLC shall be canceled.

THE COMMISSION ORDERS THAT:

- The private payphone certificate granted to Roaming Contact, LLC,
 in File Number PA-2013-0479, is canceled.
 - 2. This order shall become effective on June 20, 2018.
 - 3. This file may be closed on June 21, 2018.
