ORDER CANCELING CERTIFICATE

On May 7, 2018, JN Payphones, LLC filed notice that it was discontinuing services and asked the Commission to cancel its certificate of service authority to provide telecommunications services in the State of Missouri.

In File Number PA-2006-0484, the Commission granted JN Payphones a certificate of service authority to provide telecommunications services in the State of Missouri. Specifically JN Payphones, LLC was approved to provide pay telecommunications services.

On May 10, 2018, the Commission issued an Order Directing Staff to File a Recommendation. On May 21, 2018, Staff filed its Motion to Cancel Certificate of Service Authority stating that the company no longer wished to retain its certification to provide private pay telephone services in Missouri. Staff recommends the Commission cancel the company's certificate of service authority to provide telecommunications services.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on JN Payphones, LLC's request and Staff's recommendation, the Commission finds that the certificate of service authority granted the company, shall be canceled.

THE COMMISSION ORDERS THAT:

- 1. The certificate of authority to provide pay telecommunications services granted to JN Payphones, LLC in File Number PA-2006-0484, is canceled.
 - 3. This order shall become effective on June 29, 2018.
 - 4. This case may be closed on July 2, 2018.
