### CORRECTION ORDER APPROVING INTERIM RATES

Missouri Gas Energy (MGE or Company), a division of Southern Union Company, of Kansas City, Missouri, submitted a tariff sheet to the Commission on April 2, 1999, carrying an effective date of May 1, 1999. The tariff sheet was filed to reflect scheduled changes in MGE's Purchased Gas Adjustment (PGA) factor as a result of changes in the cost of natural gas for the upcoming summer season. Additionally, this tariff filing reflected changes in the refund, take or pay and transition cost factors, as well as termination of the Price Stabilization Charge. A Staff memorandum was filed on April 14, 1999 recommending approval. On April 19, 1999, the Commission issued its Order Approving Interim Rates (Order) approving the Eleventh Revised SHEET No. 24.7 and canceling the Tenth Revised SHEET No. 24.7 as filed on April 2, 1999.

Subsequent to the issuance of the Order, but prior to the effective date of the tariff, a typographical error was discovered in the Large Volume Transportation T. C. Factor (Factor) contained on the tariff sheet approved by the Order. The Eleventh Revised SHEET No. 24.7 contained a Factor of \$0.00891 per Ccf, which should have been \$0.00851 per Ccf. The Company's work papers which accompanied the scheduled summer PGA change reflected the correct Factor, however that Factor failed to be properly transferred onto

the tariff sheet. On April 27, 1999, MGE filed Substitute Eleventh Revised SHEET No. 24.7 with an effective date of May 1, 1999, which corrected the Factor to \$0.00851 per Ccf.

The Staff of the Commission (Staff) filed a memorandum stating that the Substitute Eleventh Revised SHEET No. 24.7 submitted on April 27, 1999 reflects the correct Factor and that all other changes contained in the tariff sheet filed on April 2, 1999 were also reflected on the substitute tariff sheet submitted on April 27, 1999. Staff recommended that the Commission approve the substitute tariff sheet to become effective May 1, 1999 on an interim basis, subject to refund.

The Commission has reviewed the tariff sheet and Staff's recommendations as filed on April 14, 1999, and April 28, 1999, and finds that the tariff sheet now contains the correct Factor and is therefore reasonable. After considering Staff's recommendation, and for good cause shown pursuant to Section 393.140(11), RSMo 1994, the Commission is of the opinion that the proposed tariff sheet, substituted on April 27, 1999, should be approved to become effective on and after the requested effective date of May 1, 1999, interim subject to refund.

#### IT IS THEREFORE ORDERED:

1. That the following tariff sheet submitted on April 2, 1999, by Missouri Gas Energy, a division of Southern Union Company, of Kansas City, Missouri, and approved by the Commission on April 19, 1999 is canceled:

2. That the tariff sheet substituted on April 27, 1999, by Missouri

Gas Energy, a division of Southern Union Company, of Kansas City, Missouri, is approved on an interim basis, subject to refund, to become effective on May 1, 1999. The tariff sheet approved is:
