
**IT IS THEREFORE ORDERED:**

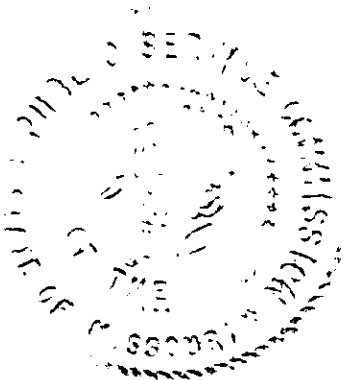
