ORDER GRANTING MOTION FOR LEAVE
TO WITHDRAW INTERVENTION, TESTIMONY AND DATA REQUESTS

On August 30, 2000, the Midwest Gas Users' Association (Midwest) filed its motion for leave to withdraw its intervention which was previously granted on March 31, 2000.

Midwest stated that there was no need for substitution of counsel since it was seeking leave to withdraw. Midwest also stated that it was withdrawing the prefiled direct testimony of John Mallinckrodt and all exhibits attached thereto.
