**DIRECTOR'S MEMORANDUM IN SUPPORT OF THE STIPULATION AND
AGREEMENT**

COMES NOW the Director of the Division of Manufactured Homes, Recreational Vehicles and Modular Units of the Public Service Commission ("Director" and "Commission") and for his *Memorandum in Support of the Stipulation and Agreement* states:

1. On August 13, 2001, the Director and Discount Manufactured Housing, Inc. ("Discount") filed a *Stipulation and Agreement* settling the outstanding issues existing between them in this case. In Paragraph 8 of that document, the Director and Discount stated that "[t]he Director shall have the right to submit to the Commission a Memorandum explaining his rationale for entering into this Stipulation [and] Agreement".

2. The rationale for the Director's participation in the *Stipulation and Agreement* is already set out in its entirety in that document. Therefore, as there is no further dispute between


the Director and Discount, the Director requests that the Commission approve the terms of the *Stipulation and Agreement* as set forth in the document, for the reasons set forth therein.
