ORDER APPROVING TARIFF FILED IN COMPLIANCE WITH COMMISSION ORDER

On July 13, 2000, the Commission issued an Order Approving Application that granted a Certificate of Convenience and Necessity to North Oak Sewer District, Inc. (North Oak) to construct, own, and operate a sewer system for the public in an unincorporated area of Warren County, Missouri.

North Oak filed tariff sheets on August 7, with an effective date of September 6. North Oak submitted substitute tariff sheets on August 29, incorporating some changes suggested by the Staff of the Commission (Staff). Staff reviewed the tariff sheets and filed a Recommendation and Memorandum on August 30, indicating that the submitted tariff contains the rates and customer classes set out in the agreement between North Oak and Staff and is in compliance with the Commission's order of July 13. Staff recommends that the Commission approve the submitted tariff sheets, effective on September 6, the requested effective date.

The Commission has reviewed the tariff sheets and Staff's recommendation and finds that the tariff sheets conform to the Commission's order of July 13 and should be approved to become effective on September 6.

IT IS THEREFORE ORDERED:

1. That the tariff filed by North Oak Sewer District, Inc. on August 7, 2000, and assigned tariff number 200100121, is approved, as amended, to become effective on September 6, 2000. The tariff approved is:

- 2. That this order shall become effective on September 6, 2000.
- 3. That this case may be closed on September 7, 2000.
