## ORDER APPROVING REVISED TARIFF

On December 11, 1998, Osage Water Company (Osage) filed an application with the Missouri Public Service Commission (Commission), requesting the issuance of a certificate of convenience and necessity to construct, install, own, operate, control, manage, and maintain a sewer system for the public in an unincorporated portion of Camden County, Missouri, known as Golden Glade Subdivision (service area).

On December 15, 1998, the Commission issued an order and notice of application, directing interested parties to file applications to intervene no later than January 14, 1999. On January 12, 1999, the City of Osage Beach filed a timely application to intervene, which was granted on January 22, 1999.

An evidentiary hearing was held June 17 and 18, 1999, where all the parties were represented. On October 14, 1999, the Commission entered its report and order, granting Osage's application.

On February 16, 2000, Osage filed tariff sheets which were revisions of P.S.C. Mo. No. 1, 1<sup>st</sup> revised sheet 5, canceling P.S.C. Mo. No. 1 original sheet 8; 2<sup>nd</sup> revised sheet 7, canceling P.S.C. Mo. No. 1, 1<sup>st</sup> revised sheet 7; and 1<sup>st</sup> revised sheet 8, canceling P.S.C. Mo. No. 1, original sheet 8. The tariff sheets described the service area for Osage's sewer service. On March 13, 2000, Osage filed substitute tariff sheets which were 1<sup>st</sup> revised sheet 5, canceling P.S.C. Mo. No. 1, original sheet 5; 2<sup>nd</sup> revised sheet 7, canceling P.S.C. Mo. No. 1, 1<sup>st</sup> revised sheet 7; and 1<sup>st</sup> revised sheet 8, canceling P.S.C. Mo. No. 1, original sheet 8. These tariff sheets also described the service area for Osage's sewer service and were, according to Osage, filed at the request of the Staff of the Commission (Staff). All of the tariff sheets reflect the changes to Osage's Missouri service area which resulted from the report and order as issued by the Commission.

On March 21, 2000, Staff filed a memorandum stating that it had reviewed the filed tariff sheets and was of the opinion that they were in compliance with the Commission's report and order and recommended that the Commission approve the proposed tariff sheets, as filed on February 16, 2000, with revisions being filed on March 13, 2000, to become effective on March 31, 2000.

The Commission finds that the revised tariff number 200000734 filed on February 16, 2000, with revisions being filed on March 13, 2000, shall be approved to become effective on March 31, 2000.

**IT IS THEREFORE ORDERED:**

1. That the revised tariff sheets, filed by Osage Water Company under tariff number 200000734, on February 16, 2000, with revisions being filed on March 13, 2000, and being 1<sup>st</sup> revised sheet 5, canceling P.S.C. Mo. No. 1, original sheet 5; 2<sup>nd</sup> revised sheet 7, canceling P.S.C. Mo. No. 1, 1<sup>st</sup> revised sheet 7; and 1<sup>st</sup> revised sheet 8, canceling P.S.C. Mo. No. 1, original sheet 8, are approved to become effective on March 31, 2000.
2. That this order shall become effective on March 31, 2000.
3. That this case may be closed on April 1, 2000.
