## ORDER APPROVING TARIFF

By Order issued on September 29, 1998, the Commission granted to LDD, Inc. (LDD) certificates of service authority to provide basic local and local exchange telecommunications services in Missouri. LDD's interconnection agreement with Southwestern Bell Telephone Company was approved on July 21, 1998 in Case No. TO-98-492. The September 29 order waived the filing of a 45-day tariff as required by 4 CSR 240-2.060(4)(H) until 30 days after the effective date of that order. LDD's certificates of service authority will become effective upon the effective date of its approved tariffs.

LDD filed tariff sheets on November 2, with an original effective date of December 17. The effective date was subsequently extended several times and the tariff currently has an effective date of February 4, 1999. The tariff sheets outline the rates, rules, regulations and services which LDD will provide as a facilities based and resold service provider to residential and business customers. LDD filed substitute tariff sheets on December 30.

The Commission's Staff reviewed the tariff sheets and filed a memorandum on January 26 recommending that the Commission approve them as amended by the substitute sheets, to become effective on February 4.

The Commission has reviewed the tariff sheets and Staff's recommendation and finds that the tariff sheets, as amended, conform to the Commission's Order of September 29 and should be approved to become effective on February 4. The Commission concludes that the conditions stated in the September 29 order granting LDD certificates of service authority to provide basic local and local exchange telecommunications service have been satisfied and the certificates will take effect on February 4.

## IT IS THEREFORE ORDERED:

1. That the tariff filed by LDD, Inc. on November 2, 1998, and assigned tariff number 9900360, is approved as amended to become effective on February 4, 1999. The tariff approved is:

- 2. That the certificates of service authority granted to LDD Local Services, Inc. on September 29, 1998, to provide basic local and local exchange telecommunications services shall become effective on February 4, 1999.
